RULES:

The CSCA applies the Rules of Curling for General Play, as approved by Curling Canada, with the following exceptions:

- 1- The opposing team cannot sweep the first 3 rocks out, if you do replace the rock were you think it would have stopped..
- 2- If your rock doesn't pass the hog line, it's a hogged rock.
- 3- If your game ends in a tie, draw to the button, sweeping aloud as per stick curling rules.
- 4- On your first game March 30th , winners move to the right , Losers move to the left.
